Encourages the provision of an appropriate site in Arlington National Cemetery for a memorial marker to honor the memory of those 14 soldiers, as long as the Secretary of the Army has exclusive authority to approve the design and site of the marker.

- **May 24, 2013:** Referred to the Subcommittee on Disability Assistance and Memorial Affairs.
- **May 21, 2013:** Introduced in House
- **May 21, 2013:** Referred to the Committee on Armed Services, and in addition to the Committee on Veterans' Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
