Summary (as of Dec 16, 2013)

Nullifying Unconstitutional Mandate By Evaluating Results Act or the NUMBER Act - Repeals the Patient Protection and Affordable Care Act and the health care provisions of the Health Care and Education and Reconciliation Act of 2010, effective as of their enactment, unless the Comptroller General certifies to Congress that at least 7 million individuals have been successfully enrolled in qualified health plans through a health care exchange during the enrollment period ending on March 31, 2014.

Actions Timeline

- **Dec 27, 2013:** Referred to the Subcommittee Indian and Alaska Native Affairs.
- **Dec 20, 2013:** Referred to the Subcommittee on Health.
- **Dec 16, 2013:** Introduced in House
- **Dec 16, 2013:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Ways and Means, Education and the Workforce, the Judiciary, Natural Resources, House Administration, Rules, and Appropriations, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
