Nashua River Wild and Scenic River Study Act - Amends the Wild and Scenic Rivers Act to designate certain segments concerning the Nashua River in Massachusetts for study for potential addition to the National Wild and Scenic Rivers System.

Directs the Secretary of the Interior to complete a study of the Nashua River in Massachusetts and New Hampshire and to report to Congress.
