### Summary (as of Mar 6, 2014)

Farmer Identity Protection Act - Prohibits the Environmental Protection Agency (EPA), or any EPA contractor or cooperator, from disclosing the information of any owner, operator, or employee of a livestock operation provided to EPA by a livestock producer or a state agency in accordance with the Federal Water Pollution Control Act (commonly known as the Clean Water Act) or any other law, including: (1) names; (2) telephone numbers; (3) e-mail addresses; (4) physical addresses; (5) global positioning system coordinates; or (6) other information regarding the location of the owner, operator, livestock, or employee.

Prescribes criteria for such a disclosure, however, in a statistical or aggregate form without specifically identifying information.

- **Mar 6, 2014:** Introduced in House
- **Mar 6, 2014:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Transportation and Infrastructure, Agriculture, and Science, Space, and Technology, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
