Summary (as of Feb 6, 2013)

Require Presidential Leadership and No Deficit Act or Require a PLAN Act - Directs the President, if his budget for FY2014, as submitted to Congress, results in a projected deficit in every fiscal year for which estimates are provided in it, to submit by April 1, 2013, a supplemental unified budget (the total level of outlays, total level of receipts, and the resulting deficit or surplus of the U.S. government for a fiscal year).

Requires a supplemental unified budget to include:

- the information required by law for the President's budget,
- an estimate of the earliest fiscal year in which the supplemental budget is not projected to result in a deficit,
- a detailed description of additional policies to be implemented in order to achieve such result (including an evaluation of duplicative agency functions and agency effectiveness, and proposals for consolidating duplicative functions and programs between agencies in the interests of cost-savings),
- an explanation of the differences between the President's original FY2014 budget and the supplemental unified budget, and
- an estimate of the cost per taxpayer of the annual deficit for each year in which the supplemental unified budget is projected to result in a deficit.

Requires the unified budget to include, under a separate heading entitled "Direct Spending," a category for "Means-Tested Direct Spending and a category for "Nonmeans-Tested Direct Spending" which specify:

- the average rate of growth for each category in the total amount of outlays during the 10-year period preceding the budget year,
- information on the budget proposals for reform of such programs,
- a description of programs which shall be considered means-tested direct spending and nonmeans-tested direct spending, and
- an annual estimate of the total amount of outlays for each such program for the period covered by the budget proposal.

Actions Timeline

- **Feb 6, 2013:** GENERAL DEBATE - The Committee of the Whole proceeded with 30 minutes of general debate on H.R. 444.
- **Feb 6, 2013:** DEBATE - Pursuant to the provisions of H.Res. 48, the Committee of the Whole proceeded with 10 minutes of debate on the Takano amendment.
- **Feb 6, 2013:** POSTPONED PROCEEDINGS - At the conclusion of debate on the Takano amendment, the Chair put the question on adoption of the amendment and by voice vote, announced that the noes had prevailed. Mr. Takano demanded a recorded vote and the Chair postponed further proceedings on the question of adoption of the amendment until later in the legislative day.
- **Feb 6, 2013:** DEBATE - Pursuant to the provisions of H.Res. 48, the Committee of the Whole proceeded with 10 minutes of debate on the Schrader amendment.
- **Feb 6, 2013:** POSTPONED PROCEEDINGS - At the conclusion of debate on the Schrader amendment, the Chair put the question on adoption of the amendment and by voice vote, announced that the noes had prevailed. Mr. Schrader demanded a recorded vote and the Chair postponed further proceedings on the question of adoption of the amendment until later in the legislative day.
- **Feb 6, 2013:** DEBATE - Pursuant to the provisions of H.Res. 48, the Committee of the Whole proceeded with 10 minutes of debate on the Fleming amendment.
- **Feb 6, 2013:** DEBATE - Pursuant to the provisions of H.Res. 48, the Committee of the Whole proceeded with 10 minutes of debate on the Messer amendment.

- **Feb 6, 2013:** The House rose from the Committee of the Whole House on the state of the Union to report H.R. 444.
- **Feb 6, 2013:** The previous question was ordered without objection. (consideration: CR H392)
- **Feb 6, 2013:** The House adopted the amendments en gross as agreed to by the Committee of the Whole House on the state of the Union.
- **Feb 6, 2013:** Ms. Schwartz moved to recommit with instructions to The Budget. (consideration: CR H392; text: CR H392)
- **Feb 6, 2013:** DEBATE - The House proceeded with 10 minutes of debate on the Schwartz motion to recommit with instructions. The instructions contained in the motion seek to report the same back to the House forthwith with an amendment to replace the partisan findings in the bill with new findings stating that every bipartisan commission and the majority of Americans believe we should take a balanced, bipartisan approach to reducing the deficit that includes revenue and spending and that sequestration would impose deep cuts to crucial domestic priorities and defense.
- **Feb 6, 2013:** The previous question on the motion to recommit with instructions was ordered without objection. (consideration: CR H393)
- **Feb 6, 2013:** On motion to recommit with instructions Failed by recorded vote: 194 - 229 (Roll no. 37). (consideration: CR H393-394)
- **Feb 6, 2013:** Passed/agreed to in House: On passage Passed by recorded vote: 253 - 167 (Roll no. 38).
- **Feb 6, 2013:** On passage Passed by recorded vote: 253 - 167 (Roll no. 38).
- **Feb 6, 2013:** Motion to reconsider laid on the table Agreed to without objection.
- **Feb 5, 2013:** Rule H. Res. 48 passed House.
- **Feb 5, 2013:** Considered under the provisions of rule H. Res. 48. (consideration: CR H364-368)
- **Feb 5, 2013:** Rule provides for consideration of H.R. 444 with 1 hour of general debate. Previous question shall be

considered as ordered without intervening motions except motion to recommit with or without instructions. Measure will be considered read. Specified amendments are in order. The resolution waives all points of order against consideration of the bill, and amendments printed in the report. Each amendment shall not be subject to amendment, and shall not be subject to a demand for division of the question in the House or in the Committee of the Whole.

- **Feb 5, 2013:** House resolved itself into the Committee of the Whole House on the state of the Union pursuant to H. Res. 48 and Rule XVIII.
- **Feb 5, 2013:** The Speaker designated the Honorable Rob Bishop to act as Chairman of the Committee.
- **Feb 5, 2013:** GENERAL DEBATE - The Committee of the Whole proceeded with one hour of general debate on H.R. 444.
- **Feb 5, 2013:** Mr. Price (GA) moved that the Committee now rise.
- **Feb 5, 2013:** On motion that the Committee now rise Agreed to by voice vote.
- **Feb 5, 2013:** Committee of the Whole House on the state of the Union rises leaving H.R. 444 as unfinished business.
- **Feb 4, 2013:** Rules Committee Resolution H. Res. 48 Reported to House. Rule provides for consideration of H.R. 444 with 1 hour of general debate. Previous question shall be considered as ordered without intervening motions except motion to recommit with or without instructions. Measure will be considered read. Specified amendments are in order. The resolution waives all points of order against consideration of the bill, and amendments printed in the report. Each amendment shall not be subject to amendment, and shall not be subject to a demand for division of the question in the House or in the Committee of the Whole.
