## Summary (as of Feb 4, 2013)

Complete America's Great Trails Act - Amends the Internal Revenue Code to allow a tax credit for the fair market value of any National Scenic Trail conservation contribution. Requires the Secretary of the Interior to study the efficacy of such tax credit in completing, extending, and increasing the number of National Scenic Trails.

## Actions Timeline

- **Feb 12, 2013:** Referred to the Subcommittee on Public Lands and Environmental Regulation.
- **Feb 4, 2013:** Introduced in House
- **Feb 4, 2013:** Referred to the Committee on Ways and Means, and in addition to the Committee on Natural Resources, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
