### Summary (as of Feb 5, 2013)

Homeland Security Respect for Life Act - Prohibits funds appropriated for the Department of Homeland Security (DHS) from being used to: (1) pay for an abortion, except in a case where a pregnant detainee suffers from a physical disorder, injury, or illness that would place the detainee in danger of death unless an abortion is performed, including a life-endangering physical condition caused by, or arising from, pregnancy itself, or in a case of rape or incest; or (2) require any person to perform, or facilitate in any way the performance of, any abortion.

## Actions Timeline

- **Feb 28, 2013:** Referred to the Subcommittee on the Constitution And Civil Justice.
- **Feb 8, 2013:** Referred to the Subcommittee on Health.
- **Feb 5, 2013:** Introduced in House
- **Feb 5, 2013:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
