Summary (as of Jul 11, 2014)

HUBZone Equity Act - Amends the Small Business Act to redefine "HUBZone small business concern" as a small business concern that is at least 51% owned and controlled by U.S. citizens (as under current law) or lawful permanent residents of the United States.
