Res. 544, the Chair put the question on ordering the previous question, and by voice vote announced that the ayes had prevailed. Mr. McGovern demanded the yeas and nays, and the Chair postponed further proceedings on ordering the previous question until later in the legislative day. (consideration: CR H3014)

- **Apr 8, 2014:** On ordering the previous question Agreed to by the Yeas and Nays: 219 - 190 (Roll no. 169). (consideration: CR H3021-3022)
