Summary (as of May 7, 2014)

(This measure has not been amended since it was introduced. The summary of that version is repeated here.)

Provides for consideration and debate of House Report 113-415 and the accompanying resolution finding Lois G. Lerner, former Director, Exempt Organizations, Internal Revenue Service (IRS), in contempt of Congress for refusal to comply with a subpoena issued by the House Committee on Oversight and Government Reform. Makes it in order, upon adoption of such resolution, without intervention of any point of order, to consider the resolution (H. Res. 565) calling upon Attorney General Eric H. Holder, Jr., to appoint a special counsel to investigate the targeting by IRS of conservative nonprofit advocacy groups.

Actions Timeline

- **May 7, 2014:** Considered as privileged matter. (consideration: CR H3458-3477)
- **May 7, 2014:** DEBATE - The House proceeded with one hour of debate on H. Res. 568.
- **May 7, 2014:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 568, the chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mr. McGovern demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question on the resolution until later in the legislative day.
- **May 7, 2014:** Considered as unfinished business. (consideration: CR H3479-3480)
- **May 7, 2014:** On ordering the previous question Agreed to by the Yeas and Nays: 223 - 192 (Roll no. 197). (consideration: CR H3479)
- **May 7, 2014:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 224 - 187 (Roll no. 198). (text: CR H3458)
- **May 7, 2014:** On agreeing to the resolution Agreed to by recorded vote: 224 - 187 (Roll no. 198). (text: CR H3458)
- **May 7, 2014:** Motion to reconsider laid on the table Agreed to without objection.
- **May 6, 2014:** Introduced in House
- **May 6, 2014:** The House Committee on Rules reported an original measure, H. Rept. 113-439, by Mr. Nugent.
- **May 6, 2014:** H. Res. 568 also provides for consideration of House Report 113-415 and an accompanying resolution under a closed rule. If such a resolution is considered, the rule provides for 50 minutes of debate on said resolution followed by one motion to refer, if offered by Representative Cummings or his designee and is debatable for 10 minutes.
- **May 6, 2014:** Placed on the House Calendar, Calendar No. 103.
