Summary (as of May 6, 2014)

Sets forth the rule for consideration of the bill (H.R. 4438) to amend the Internal Revenue Code of 1986 to simplify and make permanent the research credit.

Actions Timeline

- **May 7, 2014:** Mr. Cole called up H.Res. 569 as a privileged resolution.
- **May 7, 2014:** The Chair recognized Mr. Danny Davis and a Member opposed to each control 10 minutes of debate on the question of consideration. Following debate, the Chair put the question of consideration as the statutory means of disposing of the point of order.
- **May 7, 2014:** On motion that the House consider the resolution Agreed to by voice vote.
- **May 7, 2014:** Considered as privileged matter. (consideration: CR H3465-3471)
- **May 7, 2014:** DEBATE - The House proceeded with one hour of debate on H. Res. 569.
- **May 7, 2014:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 569, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mr. Hastings (FL) demanded the yeas and nays, and the Chair postponed further proceedings on the question until later in the legislative day.
- **May 7, 2014:** Considered as unfinished business. (consideration: CR H3480-3481)
- **May 7, 2014:** On ordering the previous question Agreed to by the Yeas and Nays: 225 - 191 (Roll no. 199). (consideration: CR H3479, H3480-3481)
- **May 7, 2014:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 230 - 188 (Roll no. 200). (text: CR H3465)
- **May 7, 2014:** On agreeing to the resolution Agreed to by recorded vote: 230 - 188 (Roll no. 200). (text: CR H3465)
- **May 7, 2014:** Motion to reconsider laid on the table Agreed to without objection.
- **May 6, 2014:** Introduced in House
- **May 6, 2014:** The House Committee on Rules reported an original measure, H. Rept. 113-440, by Mr. Cole.
- **May 6, 2014:** All points of order against consideration of the bill are waived. The amendment in the nature of a substitute recommended by the Committee on Ways and Means now printed in the bill shall be considered as adopted.
- **May 6, 2014:** Placed on the House Calendar, Calendar No. 104.
