Sets forth the rule for consideration of the resolution (H. Res. 567) providing for the Establishment of the Select Committee on the Events Surrounding the 2012 Terrorist Attack in Benghazi.

Actions Timeline

- **May 8, 2014:** DEBATE - The House proceeded with one hour of debate on H. Res. 575.
- **May 8, 2014:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 575, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mr. Polis demanded the yeas and nays, and the Chair postponed further proceedings on the question until later in the legislative day.

- **May 8, 2014:** On ordering the previous question Agreed to by the Yeas and Nays: 223 - 192 (Roll no. 206). (consideration: CR H3969-3970)
- **May 8, 2014:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 224 - 192 (Roll no. 207).(text: CR H3953)
- **May 8, 2014:** On agreeing to the resolution Agreed to by the Yeas and Nays: 224 - 192 (Roll no. 207). (text: CR H3953)
- **May 8, 2014:** Motion to reconsider laid on the table Agreed to without objection.
- **May 7, 2014:** Introduced in House
- **May 7, 2014:** The House Committee on Rules reported an original measure, H. Rept. 113-443, by Mr. Sessions.
- **May 7, 2014:** Rule provides for consideration of H. Res. 567 with 1 hour of general debate. Previous question shall be considered as ordered without intervening motions. Measure will be considered read. Bill is closed to amendments.
