- **May 20, 2014:** Motion to reconsider laid on the table Agreed to without objection.
- **May 19, 2014:** Introduced in House
- **May 19, 2014:** The House Committee on Rules reported an original measure, H. Rept. 113-455, by Mr. Woodall.
- **May 19, 2014:** All points of order against the bills are waived. General debate shall not exceed one hour. After general debate the bills shall be considered for amendment under the five-minute rule. In lieu of the amendment in the nature of a substitute recommended by the Committee of Armed Services for H.R. 4435, an amendment in the nature of a substitute consisting of the text of Rules Committee Print 113-44 shall be considered as adopted and considered as an original bill for the purposes of amendment.
- **May 19, 2014:** Placed on the House Calendar, Calendar No. 108.
