In lieu of the amendment in the nature of a substitute for H.R. 4681, an amendment in the nature of a substitute printed in Rules Committee Print 113-45 shall be considered as an original bill. No amendment to the amendment in the nature of a substitute shall be made in order except those printed in the report.
