- **Jun 24, 2014:** The House Committee on Rules reported an original measure, H. Rept. 113-493, by Mr. Bishop (UT).
- **Jun 24, 2014:** For H.R. 4899, the rule makes in order only those further amendments printed in the report. For H.R. 4293, the rule provides that the bill shall be considered for amendment under the five-minute rule. All amendments shall be debatable for 10 minutes equally divided and controlled by the proponent and an opponent and shall not be subject to amendment.
- **Jun 24, 2014:** Placed on the House Calendar, Calendar No. 116.
