Waives a specified requirement of Rule XIII (Calendar and Committee Reports) to allow consideration of any resolution reported from the Committee on Rules through the legislative day of September 5, 2014, providing for consideration or disposition of a measure relating to the ongoing humanitarian crisis on the U.S. southern border, border security, and related immigration law, on the same day it is presented to the House.

- **Jul 31, 2014:** Rule waives the requirement for a two-thirds vote to consider a report from the Committee on Rules on the same day it is presented to the House with respect to any resolution reported through September 5, 2014 providing for consideration or disposition of measures relating to the ongoing humanitarian crisis on the U.S. southern border, border security, and related immigration law. The rule also makes it in order at any time through the legislative day of September 5, 2014, for the Speaker to entertain motions that the House suspend the rules on measures addressing the ongoing humanitarian
- **Jul 31, 2014:** Placed on the House Calendar, Calendar No. 134.
