113 HRES 371	Related bill	Oct 4, 2013: DEBATE - Mr. Cole asked unanimous consent to modify the text of H.Res. 371 with the amendment at the desk. Agreed to without objection.

(This measure has not been amended since it was passed by the Senate on August 1, 2014. The summary of that version is repeated here.)

Emergency Supplemental Appropriations Resolution, 2014 - Appropriates FY2014 supplemental funds to the Department of Defense (DOD) to assist the government of Israel with procurement of the Iron Dome defense system to counter short-range rocket threats.

Provides that the funds shall be transferred immediately only through an exchange of letters to address emergent operations in support of Operation Protective Edge, notwithstanding the U.S-Israel Iron Dome Procurement Agreement.

Designates funding provided in this joint resolution as an emergency requirement pursuant to the Balanced Budget And Emergency Deficit Control Act of 1985.

- **Aug 1, 2014:** ORDER OF BUSINESS - Mr. Sessions asked unanimous consent that it be in order at any time to take from the Speaker's table H.J.Res. 76, with the Senate amendments thereto, and to consider in the House, without intervention of any point of order, a single motion offered by the Chair of the Committee on Appropriations or his designee that the House concur in the Senate amendments; the Senate amendments be considered as read; the previous question be considered as ordered on the motion to adoption without intervening motion or demand for division of the question; and the Chair may postpone the question of adoption of the motion as though under clause 8 of rule 20.
- **Aug 1, 2014:** Mr. Rogers (KY) moved that the House agree to the Senate amendments. (consideration: CR H7205, H7236)
- **Aug 1, 2014:** The previous question was ordered without objection. (consideration: CR H7205)
- **Aug 1, 2014:** POSTPONED PROCEEDINGS - At the conclusion of debate on the Rogers (KY) motion to agree in the Senate amendments to H.J.Res. 76, the Chair put the question on agreeing to the Senate amendments and by voice vote, announced that the yeas prevailed. Mr. Rogers (KY) demanded the yeas and nays and the Chair postponed further proceedings until later in the legislative day.

- **Oct 12, 2013:** Received in the Senate. Read the first time. Placed on Senate Legislative Calendar under Read the First Time.
- **Oct 11, 2013:** Considered under the provisions of rule H. Res. 371. (consideration: CR H6497-6502)
- **Oct 11, 2013:** DEBATE - The House proceeded with 40 minutes of debate on H.J. Res. 76.
- **Oct 11, 2013:** The previous question was ordered pursuant to the rule. (consideration: CR H6502)
- **Oct 11, 2013:** POSTPONED PROCEEDINGS - The Chair announced that further proceedings on H.J. Res. 76 had been postponed.
- **Oct 11, 2013:** Considered as unfinished business. (consideration: CR H6502-6504)
- **Oct 11, 2013:** Ms. Kelly (IL) moved to recommit with instructions to Appropriations. (consideration: CR H6502; text: CR H6502)
- **Oct 11, 2013:** DEBATE - The House proceeded with 10 minutes of debate on the Kelly (IL) motion recommit with instructions. The instructions contained in the motion seek to require the bill to be reported back to the House forthwith with an amendment to replace the underlying bill with the Senate Amendment to H.J. Res. 59, Continuing Appropriations Resolution, 2014, pending reservation of a point of order.
- **Oct 11, 2013:** Point of order sustained against the motion to recommit with instructions.
- **Oct 11, 2013:** Mr. Frelinghuysen raised a point of order against the motion to recommit with instructions. Mr. Frelinghuysen stated that the amendment was not germane to the underlying bill. Sustained by the Chair.
- **Oct 11, 2013:** Ms. Kelly (IL) appealed the ruling of the chair. The question was then put on sustaining the ruling of the chair. (consideration: CR H6502)
- **Oct 11, 2013:** Mr. Frelinghuysen moved to table the appeal of the ruling of the Chair.
- **Oct 11, 2013:** On motion to table the appeal of the ruling of the Chair Agreed to by the Yeas and Nays: 226 - 195 (Roll no. 541).
