Academic Competition Resolution of 2013 - Establishes an annual academic competition in the fields of science, technology, engineering, and mathematics (STEM) to be held among students in each congressional district.

Actions Timeline

- **Feb 26, 2013:** Mrs. Miller (MI) moved to suspend the rules and agree to the resolution.
- **Feb 26, 2013:** Considered under suspension of the rules. (consideration: CR H643-647)
- **Feb 26, 2013:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 77.
- **Feb 26, 2013:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
