## Actions Timeline

- **Feb 27, 2013:** Considered as privileged matter. (consideration: CR H677-682)
- **Feb 27, 2013:** DEBATE - The House proceeded with one hour of debate on H. Res. 83.
- **Feb 27, 2013:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 83, the Chair put the question on ordering the previous question and by voice vote announced that the ayes had prevailed. Ms. Slaughter demanded the yeas and nays, and the Chair postponed further proceedings on ordering the previous question until later in the legislative day.
- **Feb 27, 2013:** Considered as unfinished business. (consideration: CR H683)
- **Feb 27, 2013:** On ordering the previous question Agreed to by the Yeas and Nays: 229 - 196 (Roll no. 51). (consideration: CR H683)
- **Feb 27, 2013:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 414 - 9 (Roll no. 52).(text: CR H677)
- **Feb 27, 2013:** On agreeing to the resolution Agreed to by the Yeas and Nays: 414 - 9 (Roll no. 52). (text: CR H677)
- **Feb 27, 2013:** Motion to reconsider laid on the table Agreed to without objection.
- **Feb 26, 2013:** Introduced in House
- **Feb 26, 2013:** The House Committee on Rules reported an original measure, H. Rept. 113-10, by Mr. Nugent.
- **Feb 26, 2013:** The resolution waives all points of order against provisions in the bill. It provides that an amendment in the nature of a substitute consisting of the text of Rules Committee Print 113-2, if offered by the Majority Leader or his designee, which shall be separately debatable for 20 minutes equally divided and controlled by the proponent and an opponent.
- **Feb 26, 2013:** Placed on the House Calendar, Calendar No. 5.
