SNAP Work Opportunities Act of 2015

This bill amends the Food and Nutrition Act of 2008 to exempt Supplemental Nutrition Assistance Program (SNAP, formerly known as the food stamp program) beneficiaries from work requirements if they are not offered a position in a state job training or workfare program.

Actions Timeline

- **Mar 9, 2015:** Referred to the Subcommittee on Nutrition.

- **Feb 24, 2015:** Sponsor introductory remarks on measure. (CR E239-240)
