Summary (as of Feb 24, 2015)

Trust Returned to the United States Taxpayer Act or the TRUST Act

Denies retirement benefits under the Civil Service Retirement System and the Federal Employees Retirement System to a Member of Congress who is convicted of any crime committed after the enactment of this Act that is a felony under federal or state law (currently, limited to specified felonies under federal law).
