114 S 173	Identical bill	Jan 13, 2015: Read twice and referred to the Committee on Finance.

Modifies the definition of "antique firearm" under the federal criminal code and the Internal Revenue Code to cover any firearm manufactured in or before the calendar year that is 100 years before the year in which a determination is made as to whether the firearm is an antique firearm (currently, any firearm manufactured in or before 1898).

- **Mar 27, 2015:** Referred to the Subcommittee on Trade.
- **Feb 26, 2015:** Introduced in House
- **Feb 26, 2015:** Referred to the Committee on Ways and Means, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
