(This measure has not been amended since it was introduced. The summary of that version is repeated here.)

Opposes a new tax on oil. Urges Congress, when considering a tax policy change, to review the detrimental impacts such change would place on industries facing economic difficulties.

Mr. Boustany demanded the yeas and nays and the Chair postponed further proceedings on agreeing to the resolution until later in the legislative day.
