Chiropractic Care Available to All Veterans Act

Amends the Department of Veterans Affairs Health Care Programs Enhancement Act of 2001 to require a program under which the Secretary of Veterans Affairs provides chiropractic care and services to veterans through Department of Veterans Affairs (VA) medical centers and clinics to be carried out at: (1) no fewer than 75 medical centers by December 31, 2014, and (2) all medical centers by December 31, 2016.

Includes chiropractic examinations and services within required VA medical, rehabilitative, and preventive health care services.

Actions Timeline

- **Mar 13, 2015:** Referred to the Subcommittee on Health.
- **Feb 27, 2015:** Introduced in House
- **Feb 27, 2015:** Referred to the House Committee on Veterans' Affairs.
