Protecting Seniors' Access to Medicare Act of 2015

(Sec. 2) Repeals sections of the Patient Protection and Affordable Care Act (and restores provisions of law amended by those sections) related to the establishment of an Independent Payment Advisory Board to develop proposals to reduce the per capita rate of growth in spending under title XVIII (Medicare) of the Social Security Act.

(Sec. 3) Rescinds specified appropriations to the Prevention and Public Health Fund for FY2017-FY2026 and each fiscal year thereafter.

- **Jun 18, 2015:** The resolution provides for consideration of H.R. 160 and H.R. 1190. Each bill is closed under the rule, and shall be debatable for 1 hour. The resolution also provides for one motion to recommit with or without instructions for both bills.
- **Jun 18, 2015:** DEBATE - Pursuant to the provisions of H. Res. 319, the amendment printed in part B of the report of the Committee on Rules accompanying this resolution shall be considered as adopted. The House proceeded with one hour of debate on H.R. 1190.

- **Jun 18, 2015:** POSTPONED PROCEEDINGS - The Chair put the question on passage of H.R. 1190 and by voice vote, announced that the ayes had prevailed.
