Summary (as of Mar 2, 2015)

Prohibits uniformed service agencies or the Department of Defense (DOD) from altering the amount of the locality-based travel and transportation per diem allowances or reimbursements to which certain uniformed service members or civilian DOD employees are entitled based on the duration of temporary duty assignments or official travel in a locality.

Nullifies the DOD policy implemented on November 1, 2014, regarding reductions in per diem allowances based on the duration of temporary duty assignments or civilian travel.

Actions Timeline

- **Aug 13, 2015:** Referred to the Subcommittee on Military Personnel.
- **Mar 2, 2015:** Introduced in House
- **Mar 2, 2015:** Referred to the Committee on Armed Services, and in addition to the Committee on Oversight and Government Reform, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
