Summary (as of Mar 4, 2015)

No Free Rides Act

Amends the Internal Revenue Code to deny the earned income tax credit to any taxpayer whose identifying social security number was issued pursuant to a work authorization obtained under any program not specifically established by law that provides aliens deferred action from removal.
