Summary (as of Feb 25, 2015)

Sets forth the rule for consideration of H.R. 5 (Student Success Act).

Actions Timeline

- **Feb 26, 2015:** By direction of the Committee on Rules, Ms. Foxx called up H. Res. 125 and asked for its immediate consideration. (consideration: CR H1180-1182)
- **Feb 26, 2015:** POINT OF ORDER AGAINST CONSIDERATION - Mr. Polis made a point of order against consideration of H. Res. 125 on the grounds that it violated section 426(a) of the Congressional Budget Act of 1974. The Chair announced that the point of order met the threshold burden under the rule and recognized Mr. Polis and a Member opposed for up to twenty minutes of debate, equally divided and controlled, on the question of consideration. Following debate, the Chair would then put the question of consideration as the statutory means of disposing of the point of order.
- **Feb 26, 2015:** On consideration of the resolution Agreed to by the Yeas and Nays: 224 - 167 (Roll no. 91). (consideration: CR H1181-1182)
- **Feb 26, 2015:** Considered as privileged matter. (consideration: CR H1180-1192)
- **Feb 26, 2015:** DEBATE - The House proceeded with one hour of debate on H. Res. 125.
- **Feb 26, 2015:** On ordering the previous question Agreed to by the Yeas and Nays: 234 - 177 (Roll no. 92). (consideration: CR H1191-1192; text CR H1191)
- **Feb 26, 2015:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 234 - 184 (Roll no. 93). (text: CR H1180)
- **Feb 26, 2015:** Motion to reconsider laid on the table Agreed to without objection.
- **Feb 26, 2015:** On agreeing to the resolution Agreed to by recorded vote: 234 - 184 (Roll no. 93). (text: CR H1180)
- **Feb 25, 2015:** Introduced in House
- **Feb 25, 2015:** The House Committee on Rules reported an original measure, H. Rept. 114-29, by Ms. Foxx.
- **Feb 25, 2015:** The rule provides for further consideration of H.R. 5. The rule provides that an amendment in the nature of a substitute consisting of the text of Rules Committee Print 114-8, modified by the amendment printed in part A of the Rules Committee report, shall be considered as adopted. No further amendment to the bill shall be in order except those printed in part B of the report of the Committee on Rules.
- **Feb 25, 2015:** Placed on the House Calendar, Calendar No. 11.
