## Summary (as of Mar 4, 2015)

### Horse Transportation Safety Act of 2015

Prohibits a person from transporting a horse in interstate commerce in a motor vehicle (except a vehicle operated exclusively on rail or rails) containing two or more levels stacked on top of one another. Prescribes civil penalties for persons who knowingly violate such prohibition.
