Service Disabled Veteran Owned Small Business Relief Act

(Sec. 2) Treats the surviving spouse of a service-disabled veteran who acquires the ownership interest in a small business of the deceased veteran as such veteran for purposes of eligibility for VA service-disabled small business contracting goals and preferences for: (1) 10 years after the veteran's death if such veteran was either 100% disabled or died from a service-connected disability, or (2) 3 years after such death if the veteran was less than 100% disabled and did not die from a service-connected disability.

- **May 19, 2015:** Received in the Senate and Read twice and referred to the Committee on Veterans' Affairs.
- **May 18, 2015:** Mr. Wenstrup moved to suspend the rules and pass the bill.
- **May 18, 2015:** Considered under suspension of the rules. (consideration: CR H3260-3261)
- **May 18, 2015:** DEBATE - The House proceeded with forty minutes of debate on H.R. 1313.
- **May 18, 2015:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
- **May 18, 2015:** Considered as unfinished business. (consideration: CR H3294)
