Summary (as of Mar 4, 2015)

Deny Amnesty Credits Act of 2015

This bill amends the Internal Revenue Code to deny the earned income tax credit and the child tax credit to any illegal alien who has received employment authorization under a program for deferred action on removal that has not been specifically authorized by law.
