Summary (as of Mar 16, 2015)

Medicare Adult Day Services Act of 2015

Amends title XVIII (Medicare) of the Social Security Act to: (1) cover certified adult day services furnished in a certified adult day services center and meeting specified requirements, and (2) require the Secretary of Health and Human Services to increase by 3% the payment amount otherwise effective for such services furnished in a rural area on or after January 1, 2016, and before January 1, 2018.

Actions Timeline

- **Mar 27, 2015:** Referred to the Subcommittee on Health.
- **Mar 16, 2015:** Introduced in House
- **Mar 16, 2015:** Referred to the Committee on Ways and Means, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
