Preventing Diabetes in Medicare Act of 2015

Amends title XVIII (Medicare) of the Social Security Act to extend Medicare coverage to medical nutrition therapy services for people with pre-diabetes and risk factors for developing type-2 diabetes.

Actions Timeline

- **Apr 8, 2015:** Referred to the Subcommittee on Health.
- **Mar 27, 2015:** Referred to the Subcommittee on Health.
- **Mar 26, 2015:** Introduced in House
- **Mar 26, 2015:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
