- Departmental Management.

Department of Health and Human Services Appropriations Act, 2016

Provides appropriations to the Department of Health and Human Services for:

- the Health Resources and Services Administration,
- the Centers for Disease Control and Prevention,
- the National Institutes of Health,
- the Substance Abuse and Mental Health Services Administration,
- the Agency for Healthcare Research and Quality,
- the Centers for Medicare and Medicaid Services,
- the Administration for Children and Families,
- the Administration for Community Living, and
- the Office of the Secretary.

Department of Education Appropriations Act, 2016

Provides appropriations to the Department of Education for:

- Education for the Disadvantaged;
- Impact Aid;

- Safe Schools and Citizenship Education;
- English Language Acquisition;
- Special Education;

Sets forth permissible, restricted, and prohibited uses for funds provided by this and other appropriations Acts. Rescinds unobligated balances from prior appropriations.
