## Summary (as of Jul 28, 2015)

Recognizes the 25th anniversary of the enactment of the Americans with Disabilities Act of 1990. Encourages celebration of the advancement of freedom and the expansion of opportunity made possible by its enactment.

Pledges continued work on a bipartisan basis to support opportunity, independent living, economic self-sufficiency, and the full participation of individuals in the United States who have disabilities.

- Jul 29, 2015: Received in the House.

- Jul 29, 2015: Referred to the Committee on Education and the Workforce, and in addition to the Committees on Transportation and Infrastructure, the Judiciary, and Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- Jul 28, 2015: Introduced in Senate
