Summary (as of Apr 16, 2015)

Expresses the sense of the House of Representatives that the House should strive to create, debate, and adopt policy solutions to achieve a National Strategic Agenda with the goals of: creating 25 million new jobs over the next 10 years, balancing the federal budget by 2030, securing Medicare and Social Security for the next 75 years, and making the United States energy secure by 2024.

Actions Timeline

- **Apr 21, 2015:** Referred to the Subcommittee on Health.
- **Apr 17, 2015:** Referred to the Subcommittee on Health.
- **Apr 16, 2015:** Introduced in House
- **Apr 16, 2015:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Ways and Means, Education and the Workforce, and the Budget, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
