#### Endangered Species Litigation Reasonableness Act

This bill amends the Endangered Species Act of 1973 to replace the current standard for awarding court costs, including attorney fees, in citizen suits with the federal judicial code standard for awarding costs to a prevailing party.

### Actions Timeline

---

- **Jun 1, 2015:** Referred to the Subcommittee on the Constitution and Civil Justice.
- **Apr 29, 2015:** Introduced in House
- **Apr 29, 2015:** Referred to the Committee on Natural Resources, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
