## Summary (as of May 20, 2015)

This bill amends title XVIII (Medicare) of the Social Security Act, with respect to the establishment of physicians' fee schedules, to extend for 2016 and each subsequent year the classification of dual-energy x-ray absorptiometry services as imaging services used in bone mass scans.

The Department of Health and Human Services shall establish national minimum payment amounts for such services as identified by specified Healthcare Common Procedure Coding System codes and adjusted by the pertinent geographical adjustment factors.

- **May 20, 2015:** Introduced in House
- **May 20, 2015:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
