Summary (as of Apr 23, 2015)

(This measure has not been amended since it was introduced. The summary of that version is repeated here.)

Permits the Grand Lodge of the Fraternal Order of Police and its auxiliary to sponsor a free public event on the Capitol grounds, namely:

- the National Honor Guard and Pipe Band Exhibition on May 14, 2015, to allow law enforcement representatives to exhibit their ability to demonstrate Honor Guard programs and provide for a bag pipe exhibition; and
- the 34th Annual National Peace Officers' Memorial Service on May 15, 2015, to honor the law enforcement officers who died in the line of duty during 2014.
