Summary (as of Jun 1, 2015)

Homeless Veterans Assistance Fund Act of 2015

Amends the Internal Revenue Code to: (1) establish in the Treasury the Homeless Veterans Assistance Fund; (2) allow individual taxpayers to designate on their tax returns a specified portion (not less than \$1) of any overpayment of tax, and to make a contribution of an additional amount, to be paid over to such Fund to provide services to homeless veterans; and (3) require the Departments of Veterans Affairs, Labor, and Housing and Urban Development, each year beginning with the President's annual budget submission for FY2017, to include a description of the use of funds from the Fund in the previous fiscal year and the proposed use of such funds for the next fiscal year.

Actions Timeline

- **Jun 5, 2015:** Referred to the Subcommittee on Health.
- **Jun 1, 2015:** Introduced in House
- **Jun 1, 2015:** Referred to the Committee on Ways and Means, and in addition to the Committee on Veterans' Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
