(This measure has not been amended since it was reported to the House on March 30, 2016. The summary of that version is repeated here.)

No Rate Regulation of Broadband Internet Access Act

(Sec. 2) This bill prohibits the Federal Communications Commission (FCC) from regulating the rates charged for broadband Internet access service.

(Sec. 3) Nothing in this Act shall be construed to affect the FCC's authority to: (1) condition receipt of universal service support by a provider of broadband Internet access service on the regulation of the rates charged by such provider for the supported service, or (2) enforce regulations relating to truth-in-billing requirements or paid prioritization.

(Sec. 4) Broadband Internet access service shall not be construed to include data roaming or interconnection for purposes of this Act.

- **Apr 15, 2016:** The Speaker designated the Honorable John J. Duncan, Jr. to act as Chairman of the Committee.
- **Apr 15, 2016:** GENERAL DEBATE - The Committee of the Whole proceeded with one hour of general debate on H.R. 2666.
- **Apr 15, 2016:** DEBATE - Pursuant to the provisions of H. Res. 672, the Committee of the Whole proceeded with 10 minutes of debate on the Yarmuth amendment no. 2.
- **Apr 15, 2016:** POSTPONED PROCEEDINGS - At the conclusion of debate on the Yarmuth amendment, the Chair put the question on adoption of the amendment and by voice vote announced that the noes prevailed. Mr. Yarmuth demanded a recorded vote, and the Chair postponed further proceedings on adoption of the amendment until later in the legislative day.
- **Apr 15, 2016:** DEBATE - Pursuant to the provisions of H. Res. 672, the Committee of the Whole proceeded with 10 minutes of debate on the McNERNEY amendment no. 3.
- **Apr 15, 2016:** POSTPONED PROCEEDINGS - At the conclusion of debate on the McNERNEY amendment, the Chair put the question on adoption of the amendment and by voice vote announced that the noes prevailed. Mr. McNERNEY demanded a recorded vote, and the Chair postponed further proceedings on adoption of the amendment until later in the legislative day.
- **Apr 15, 2016:** UNFINISHED BUSINESS - The Chair announced that the unfinished business was the question on adoption of amendments which had been debated earlier and on which further proceedings had been postponed.
- **Apr 15, 2016:** The House rose from the Committee of the Whole House on the state of the Union to report H.R. 2666.
- **Apr 15, 2016:** The previous question was ordered pursuant to the rule. (consideration: CR H1753)
- **Apr 15, 2016:** The House adopted the amendment in the nature of a substitute as agreed to by the Committee of the Whole House on the state of the Union. (text of amendment in the nature of a substitute: CR H1748-1749)
- **Apr 15, 2016:** Mr. Yarmuth moved to recommit with instructions to the Committee on Energy and Commerce. (consideration: CR H1753; text: CR H1753)
- **Apr 15, 2016:** Floor summary: DEBATE - The House proceeded with 10 minutes of debate on Yarmuth motion to recommit with instructions, pending reservation of a point of order. The instructions contained in the motion seek to require the bill to be reported back to the House with an amendment providing for consideration of H. Con. Res. 125, establishing the congressional budget for the United States Government for FY 2017.
- **Apr 15, 2016:** Point of order sustained against the motion to recommit with instructions.
- **Apr 15, 2016:** Mr. Walden raised a point of order against the motion to recommit with instructions. Mr. Walden stated that the provisions of the amendment were not germane to the bill. Sustained by the Chair.
- **Apr 15, 2016:** Passed/agreed to in House: On passage Passed by recorded vote: 241 - 173 (Roll no. 152).
