## Summary (as of Jun 12, 2015)

### Atomic Veterans Service Medal Act

This bill directs the Secretary of Defense to design and produce an Atomic Veterans Service Medal to honor retired and former members of the Armed Forces who are radiation-exposed veterans.

The Secretary may provide for issuance of the Medal to the next-of-kin of a deceased radiation-exposed veteran.
