## Summary (as of Jun 23, 2015)

### Humane Cosmetics Act

This bill prohibits testing cosmetics on animals, effective on the date that is one year after enactment of this Act. No cosmetic may be sold or transported if the final product or any component was developed or manufactured using animal testing after such date, effective three years after enactment of this Act.
