## Summary (as of Jan 8, 2015)

(This measure has not been amended since it was introduced. The summary of that version is repeated here.)

### Save American Workers Act of 2015

This bill amends the Internal Revenue Code to change the definition of "full-time employee" for purposes of the employer mandate to provide minimum essential health care coverage under the Patient Protection and Affordable Care Act from an employee who is employed on average at least 30 hours of service a week to an employee who is employed on average at least 40 hours of service a week.

### Actions Timeline

- **Mar 30, 2015:** Referred to the Subcommittee on Health.
- **Jan 12, 2015:** Read twice and referred to the Committee on Finance.
- **Jan 9, 2015:** Received in the Senate.
- **Jan 8, 2015:** Rule H. Res. 19 passed House.
- **Jan 8, 2015:** Considered under the provisions of rule H. Res. 19. (consideration: CR H125-140)
- **Jan 8, 2015:** Previous question shall be considered as ordered without intervening motions except motion to recommit with or without instructions. All points of order against the bill are waived. The bills shall be considered as read.
- **Jan 8, 2015:** DEBATE - The House proceeded with one hour of debate on H.R. 30.
- **Jan 8, 2015:** The previous question was ordered pursuant to the rule. (consideration: CR H138)
- **Jan 8, 2015:** Mr. Becerra moved to recommit with instructions to the Committee on Ways and Means. (consideration: CR H138-140; text: CR H138)
- **Jan 8, 2015:** DEBATE - The House proceeded with 10 minutes of debate on the Becerra motion to recommit with instructions, pending the reservation of a point of order. The instructions contained in the motion seek to require the bill to be reported back to the House with an amendment prohibiting the amendments in section 2 of the bill from taking effect if additional, listed conditions could be expected as a result.
- **Jan 8, 2015:** The previous question on the motion to recommit with instructions was ordered without objection. (consideration: CR H139)
- **Jan 8, 2015:** On motion to recommit with instructions Failed by the Yeas and Nays: 179 - 244 (Roll no. 13).
- **Jan 8, 2015:** Passed/agreed to in House: On passage Passed by recorded vote: 252 - 172 (Roll no. 14). (text: CR H125-126)
- **Jan 8, 2015:** On passage Passed by recorded vote: 252 - 172 (Roll no. 14). (text: CR H125-126)
- **Jan 8, 2015:** Motion to reconsider laid on the table Agreed to without objection.
- **Jan 7, 2015:** Rules Committee Resolution H. Res. 19 Reported to House. Previous question shall be considered as ordered without intervening motions except motion to recommit with or without instructions. All points of order against the bills are waived. The bills shall be considered as read.
- **Jan 6, 2015:** Introduced in House
- **Jan 6, 2015:** Referred to the Committee on Ways and Means, and in addition to the Committee on the Budget, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
