Summary (as of Jul 14, 2015)

Background Check Completion Act

This bill amends the federal criminal code to prohibit a licensed gun dealer from transferring a firearm to an unlicensed person prior to completion of a background check. (Current law permits a licensed gun dealer to transfer a firearm to an unlicensed person if a submitted background check remains incomplete after three business days.)

Actions Timeline

- **Jul 29, 2015:** Referred to the Subcommittee on Crime, Terrorism, Homeland Security, and Investigations.
- **Jul 14, 2015:** Introduced in House
- **Jul 14, 2015:** Referred to the House Committee on the Judiciary.
