## **TELEmedicine for MEDicare Act of 2015 or the TELE-MED Act of 2015**

This bill amends title XVIII (Medicare) of the Social Security Act to allow a Medicare provider to provide telemedicine services to a Medicare beneficiary who is in a different state from the one in which the provider is licensed or authorized to provide health care services. The licensing or authorizing state has jurisdiction to enforce its licensure or other legal authorization requirements with regard to such a provision of service.

### **Actions Timeline**

- **Jul 21, 2015:** Referred to the Subcommittee on Health.
- **Jul 17, 2015:** Referred to the Subcommittee on Health.
- **Jul 15, 2015:** Introduced in House
- **Jul 15, 2015:** Referred to the Committee on Ways and Means, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
