Lionfish Elimination and Prevention Act of 2015 or the LEAP Act of 2015

This bill amends the Lacey Act to prohibit the importation or interstate shipment of the:

- red lionfish of the species *Pterois volitans*,
- devil lionfish of the species *Pterois miles*,
- Hawaiian turkeyfish of the species *Pterois sphex*,
- soldier lionfish of the species *Pterois russelii*,
- clearfin lionfish of the species *Pterois radiata*,
- lionfish species *Pterois paucispinula*,
- frillfin turkeyfish of the species *Pterois mombasae*,
- luna lionfish of the species *Pterois lunulata*,
- mandritsa of the species *Pterois brevipectoralis*,
- spotfin lionfish of the species *Pterois antennata*, and
- scorpionfish of the species *Pterois andover*.
