## Summary (as of Jul 29, 2015)

### Preserving Public Access to Public Waters Act

This bill directs the Department of the Interior and the Department of Commerce to obtain approval from the relevant fish and wildlife management agency of a state or territory before restricting fishing access to state or territorial marine waters that are within the jurisdiction of the National Park Service or the Office of National Marine Sanctuaries, including coastal waters and estuaries.

- **Jul 29, 2015:** Referred to the House Committee on Natural Resources.
