## Summary (as of Jul 29, 2015)

### Resettlement Accountability National Security Act of 2015

This bill prohibits the admission of refugees into the United States until Congress passes a joint resolution giving the Department of Homeland Security authority to resume admitting refugees.

Requires the Government Accountability Office to report to Congress on refugees who received benefits under any of the following programs:

- Medicare,
- Medicaid,
- disability insurance under title II of the Social Security Act,
- the supplemental nutrition assistance program (SNAP, formerly the food stamp program), and
- section 8 rental assistance.

## Actions Timeline

- **Sep 8, 2015:** Referred to the Subcommittee on Immigration and Border Security.
- **Jul 29, 2015:** Introduced in House
- **Jul 29, 2015:** Referred to the House Committee on the Judiciary.
