Summary (as of Jul 29, 2015)

CPI-E Act of 2015

This bill bases cost-of -living increases in benefits under the Civil Service Retirement System, the Federal Employees Retirement System, military retirement and survivor benefit programs, old-age, survivors, or disability insurance benefit program, and specified veterans benefits programs on increases in the Consumer Price Index for the elderly.

Actions Timeline

- **Nov 23, 2015:** Referred to the Subcommittee on Military Personnel.
- **Aug 12, 2015:** Referred to the Subcommittee on Social Security.
- **Aug 6, 2015:** Referred to the Subcommittee on Disability Assistance and Memorial Affairs.
- **Jul 29, 2015:** Introduced in House
- **Jul 29, 2015:** Referred to the Committee on Ways and Means, and in addition to the Committees on Veterans' Affairs, Oversight and Government Reform, and Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
